

What is Coordinated Entry(CE)?

• Coordinated Entry is a streamlined process designed to assist individuals and families resolve their housing crisis by accessing valuable resources and/or safe housing in an equitable, person-centered, and transparent manner.

Who is CE designed for?

 CE is designed for Genesee County residents experiencing homelessness, or at risk of being homeless, to secure shelter and/or safe housing. Using a "no wrong door approach"

"Literally Homeless" or at "Imminent Risk of Homelessness"



What **OCCUIS** after a referral is made?

- Clients are referred out to partner housing agencies.
- **GHS**-Rapid Rehousing/ Permanent Supportive Housing
- Catholic Charities-Rapid Rehousing
- Shelter of Flint-Permanent Supportive Housing
- GCYC-Youth Programs
- Project Based Communities
- An assigned housing specialist will work with client through application/housing process.
- Required Documents: Verification of Homelessness, Personal information(ID, S.S.cards, Birth Certificates, etc. Proof of income(DHS, Social Security, unemployment/employment)
- Housing is not Guaranteed!

Expected Timeline for Securing Housing & Follow up

- The timelines for securing housing are variable. Depends on client barriers as well as available housing.
- Once a client secures housing, client or housing specialist will report outcomes back to CE Specialist
- If client declines or is not approved services, they will be referred back to CE Specialist.
