I. WELCOME: Meeting called to order by Essence Wilson

II. OLD BUSINESS:

- A. Approval of July 2022 minutes: Minutes were approved
- **B.** Governance Council update: Essence Wilson gave the Governance Council update.
 - The Grievance Workgroup is still meeting and working and hopes to have something to present in September for input, comment, and approval.
 - Jim Hudgens has decided to resign from the Executive Council in his role as Vice Chair of Programs. If you know someone interested in filling in for that role, please contact the nominating committee.
 - The Leadership Group (TLG) is still working on the Strategic Mapping Process. They have
 narrowed us down to key areas and now putting together focus groups. If you have gotten an
 invitation to be a part of a focus group, please be in attendance. There will also be other
 opportunities in the future to share input with TLG.
- C. Nominating Committee Update: Greg Abler gave the Nominating Committee update. The slate for the IRT (Independent Review Team) will be presented today and should be ready to vote on at next month's CoC meeting. The Charter mandates that the IRT has from 5 to 9 members. Mr. Abler said it seems simple until you look at the eligibility requirements for IRT members. The IRT must be free of any conflict of interest. IRT members cannot be on the board or staff of an agency that receives CoC funds.

Everybody on the proposed slate has some knowledge in the key areas. The nominating committee ended up with 6 individuals on the slate. Egypt Otis, not in the CoC, owner of Comma Bookstore in Flint. Tiffani Wharry from Family Promise of Genesee County, Lisa Humphrey of Big Brother/Big Sister of Genesee County, Tryphena Clarke from Ruth Mott Foundation, Tarnesa Martin from Hurley Medical Center, and Sonyita Clemons. This is the slate to review. Contact the nominating committee with questions or concerns.

III. OTHER BUSINESS:

A. MSHDA ESG FY22-23 NOFA

- Shelly Safi reported more agencies asked for additional funding than we have available. MSHDA
 ESG did come out with a total amount of \$261,763 which was a deduction of 4% from last year's
 award. There were 6 agencies that applied for funding.
- Angela Beaugard reported that we remained in alignment with prior year funding within the MSHDA parameters. The recommendation required all entities to adjust to the 4% percent funding decrease but continued with our aligned focus on Rapid Rehousing supports. Funded programs must be programs of organizational member in good standing. Members are expected to attend at least 9 out of 12 regularly scheduled CoC general membership meetings, to read all meeting materials, and to actually participate in discussions to ensure informed voting. The funding recommendations were presented to the general membership to be voted on.
- RECOMMENDATIONS WERE VOTED ON AND APPROVED

B. FY2022 CoC Program NOFO

Tracey Hurd reported that on August 1, 2022, HUD released the announcement of the FY2022 CoC Program NOFO, the due date for the FY2022 NOFO is September 30 2022. The HUD SNAPs office is facilitating a NOFO Office Hours meeting tomorrow August 11th. More information should be available to share. Ms. Hurd reminding the group that if HUD does not relax the 30-day prioritization we will have to have everything completed and ready for prioritization by August 26th. Tentatively we will schedule the prioritization meeting for Friday August 26th. We will release the CoC Application (the narrative) as soon as it is made available. Your input is welcomed. Ms. Hurd stated that we will have to move quickly but she is confident we can do it.

C. FY2022 NOFO Unsheltered Homelessness

Ms. Hurd stated that this is due October 13th. We are prepared to complete the CoC Program NOFO then jump right into this and complete within two weeks. The MCD team has not fully studied the Unsheltered Homelessness NOFO, but Tracey briefly explained what they are looking for. Ms. Hurd stated that in our community the top reasons people choose not to go into a shelter or can't get into a shelter is, they have a criminal sexual conduct charge, they have some kind of mental paranoia, or they have a pet. Under sheltered increase capacity we can submit something for non-congregate shelter, which would be hotel-motel. We would talk to agencies and if agency wants to have that program just let us know. Stay tuned for more details.

Essence Wilson put a link in the chat to the Grant.Gov website. She stated that we should dive into the Unsheltered Homelessness NOFO and learn what the allowable uses are. There are some provisions as well for actual supportive services. Essence mentioned that we also have a population of folks with physical disabilities that are not able to go into shelters. We need to think more broadly and explore other reasons people refuse to go to the shelter.

IV. REPORTS:

- **A. Housing Assessment and Resource Agency:** Please view HARA report. Misty stated that for the month of July, Catholic Charities had 3,350 incoming calls and 579 walk-ins. The homeless prevention program spent \$9,434.96 and assisted 14 households. The Rapid Re-Housing program spent \$2,903.14 and assisted 4 households. The Housing Choice Voucher (HCV) program has 200 people on the waitlist. Becka management last pulled from the homeless preference waitlist on 7-6-22, 30 names were pulled; they pulled up to March 18th. The Emergency Housing Voucher (EHV) program spent \$3,978.73 and assisted 3 people. The CERA (COVID Emergency Rental Assistance) program at Catholic Charities spent \$856,261.13 and has assisted 246 households.
 - 1. **GCCARD** -- The CERA (COVID Emergency Rental Assistance) program at GCCARD spent \$572,349.99 on rent and utilities.
- **B.** Continuous Quality Improvement (CQI): No report submitted. The goal of the CQI is to determine and implement the best practice for an effectively functioning coordinated entry system. This committee is currently reviewing performance objectives. Meetings are 3rd Thursday at 1:00pm via ZOOM.
- **C. Street Outreach: No update given.** More people understand that they have to be verified homeless in order to receive services. The requests are coming in, but they are not qualifying to be homeless.
- **D.** Coordinated Entry System (CES): Please view CES report. Eric Cooper stated that he received 49 CESA forms in the month of July. Eric sent out 16 referrals and 1 person was housed.
- E. HMIS: Please view HMIS report. Data quality in HMIS has greatly improved.
- F. Supplemental Social Security Income & Social Security Disability Insurance Outreach Access and Recovery (SOAR): Please view SOAR report. Bill reported one approval. Bill also stated that 8 people have signed up to take the SOAR training. Contact Bill Doub for more information at (810) 618-6045 or wdoub@genhs.org. SOAR meetings are held via ZOOM on the 3rd Thursday of every month.
- **G. Fiscal Reports:** The Fiscal Work Group Subcommittee has restarted. Meetings are held via ZOOM on the 4th Thursday of every month at 10 AM. Moving forward the Fiscal Work Group Chairperson will produce a report and what was discussed will be reported out at the next CoC monthly meeting.
