I. WELCOME—Essence started the meeting by welcoming the CoC members and stating the CoC's mission. "A community working together to achieve access to safe and affordable housing for all residents of Genesee County.

II. COMMUNITY PRESENTATION

- A. Becka Management- Glory White gave an overview on Becka Management's voucher program.
 - 1. Glory White- Once we received our open vouchers from MSHDA, we pull from that waitlist, and we factor into the number of vouchers that we received a 10% to cover vouchers we may have terminated during that month.
 - 2. Once a name is pulled from the waitlist, a letter is sent out to the address of the applicants. The HARA receives a copy of the pulled list with addresses and phone numbers. If an applicant pulled from the waitlist does not update their address, an examination will be made on their application to verify if there is a secondary address. If the person does not respond in 14 days, they must reapply. Also, there is a list of personal documents that need to be submitted with the application. Those documents include birth certificates and social security cards from everyone in the household. A State I.D. is required of anyone that is 18 years or older. Anyone that does not have their personal documents such as their birth certificate or state I.D. must go to an agency like First Presbyterian Church. Everyone has 14 days to submit their packet.
 - 3. After we receive the documents/packet in the Lansing Becka Office, that individual is given a background check to verify that the individual is not over the income for their family size. Once this is completed, the person will be briefed on the program. They will receive a moving packet and a voucher.
- B. Catholic Charities- Katie Baxter briefly explained the purpose of the Warming Center.
 - 1. The Warming Center was established in 2010 by Catholic Charities. The Basic Needs Committee received complaints and concerns about individuals that were homeless hanging out and sleeping overnight in front of storefronts. Briefly the Resource Center used their day center at night to accommodate 30-40 individuals.

- 2. Over the years the Warming Center has continually served over 100 clients. Keep in mind The Warming Center is not a shelter and there is limited spacing. So, it's been a real challenge. As the volume increased, more safety, health and expenses issues have increased. Also, we have individuals coming from surrounding counties. In the past three years the Warming Center has seen a dramatic increase. From 2020-2021 the Warming Center receive about 60 clients for serving. From 2021-2022 an average of 80 clients for serving and over 100 clients, including nearly 140 for some nights were served throughout 2023.
- 3. Currently we have a proposed pilot program that will expand the Warming Center at the North End Soup Kitchen. We're looking to accommodate up to 30 individuals and that would decrease some of the number of individuals coming in at Center of Hope. We will serve 2 hot meals daily, and 1 hot meal on Sunday, 365 days a year. This expansion does not resolve every issue, nor is the expansion is perfect solution.
- 4. Our long-term goals are to create one designated space to manage the growing number of people. We want the ability to separate men from women and children. But there would need to be facilities, upgrades and one dedicated space to manage that elsewhere. One location would eliminate additional cost of facility, food, and staff expenses.

III. OLD BUSINESS

- A. July 2023 minutes were approved.
- B. Governance Council update-No current updates from the Governance Council.
- C. Infrastructure and Coordinated Entry RFP Update— Essence advised the CoC members that she is currently working to schedule a meeting with the members of the IRT, along with a few community members who represent agencies that are not interested in bidding on either of those. And the 2 things that we're really looking at are going to be the timeline, and to make sure that the content is as thorough as possible. So, there will be more to come for this group while those 2 RFPs are being prepared for release by any agency.

IV. NEW BUISINESS:

- A. **FY2023–2024 MSHDA ESG NOFA:** Shelly Safi advised the CoC that the application for MSHA ESG is due August 18. But the applications from the sub-recipients are due to her by August 11th.
 - 1. Genesee County Youth Coalition (GCYC), My Brother's Keeper (MBK) & Shelter of Flint (SOF) received \$26,176.00 for emergency shelter. Catholic Charities received homeless prevention funds of \$75,000. Both Catholic Charities and MBK received \$31,213.00 for Rapid Re-Housing. Catholic Charities received \$26,176.00 for HMIS and \$19,632.00 for Administrative Cost.
 - 2. The eligible agencies voted on the MSHDA FY2023-2024 ESG. Please see attachment for results

V. OTHER BUSINESS:

- A. **FY2023 CoC Program NOFO Update:** Tracey Hurd gave an update/overview for the FY2023 NOFO CoC Program. Every year the Department of Housing and Urban Development (HUD) sends out the Notice of Funding Opportunity to 400 plus CoC's across the nation. NOFO is a competitive program and funding is not guaranteed.
 - 1. This year's NOFO is due September 28, 2023 by 8:00 PM. There are two components to the Consolidated Application process: the Priority Listing and the CoC Application.

- 2. Our CoC has 14 programs that equal to \$2.5 million, \$2.388 million of that funding is connected to programs. CoC Planning is not considered a program by HUD standards.
- 3. In this NOFO, HUD will allow expansion and consolidation. We did consolidation last year with Shelter of Flint. There are no other agencies that are eligible for consolidation. So, we could submit another expansion. For New Projects we can potentially submit a new application for CoC Bonus, DV Bonus and Reallocation. There's a couple of ways that you can bring new projects to the table for application, and HUD tends to approve new projects if there is some reallocation involved.
- 4. Match is a very important component in our CoC NOFO. Budget Line Items (BLI) require 25% match. The only exception is the leasing portion of a grant. For example, for a program that is \$138,000. You must provide \$34,500 for a match. That commitment, and that letter is due at the time of application submission.

VI. REPORTS:

- A. Housing Assessment Resource Agency: Misty Bowers presented the HARA reports for the month of July. The total incoming calls were 3,102, we had 391 walk-ins, and 44 referrals to Crossover Outreach. For homeless prevention we assisted a total of 36 people with a total of 32,443.06 spent. We just hired a case manager for rapid rehousing. And so, we'll be asking for referrals on that, and moving forward. For the Housing Choice Voucher (HCV) we had 200 on the waitlist. Outreach with EFSP funds spent \$2,584.00 for rental assistance, \$7,051.10 was spent on utility assistance and a total of \$9,635.10. A total of \$562,747.02 was sent out of the CERA fund.
- B. Continuous Quality Improvement (CQI): No report submitted.
- C. Street Outreach: No Report Submitted.
- D. Coordinated Entry System (CES): Eric Cooper reported for the Month of July that the Coordinated Entry System received 77 CESA's forms. We sent out 9 referrals for housing opportunities.
- E. Interagency Service Team (IST): The last IST meeting was very brief. We had been working with Jim Perlaki and his CQI team. We had been doing in person meetings. We were discussing problems and solutions and next steps for people returning to homelessness. Last month we just discussed animal care for people that are experiencing homelessness with animals. And as far as moving up goes none of the Case Managers had anyone to move up for the month. If you have any questions about my report or if you want more clarity. Please email me. - G. Supplemental Social Security Income & Social Security Disability Insurance Outreach Access and Recovery (SOAR) 80% rates for all applications are officially tracked as of 5 years ago. Also, one quick note in the HUD renewal application form. There is a line where you check a box that says you're going to assist clients with applying for benefits specifically social security using the SOAR initiative +69. For more information on the SOAR program Please view SOAR report. If interested in becoming a SOAR practitioner, please contact Bill Doub for more information at (810) 618-6045 or wdoub@genhs.org. SOAR training can be done in a group cohort or individually. The monthly SOAR meetings are held via ZOOM on the 3rd Thursday of every month at 10am.
- H. **Fiscal Reports:** The purpose of the fiscal workgroup is to review spending of agencies. The Fiscal Workgroup meetings are held via ZOOM on the 4th Thursday of each month at 10 Am.

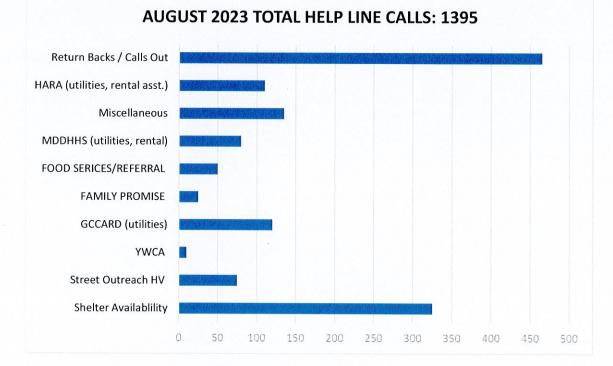

Qualitative: barriers and solutions

- Barriers identified: Behavioral issues being a barrier to housing a client with mental health and/or SUD concerns.
 - 1. Landlords being unwilling to rent to CoC's homeless community due to damage to their units.
 - 2. Some individuals have limited knowledge on how to be a good tenant or how to manage a household.
 - 3. Lack of "life skills" for some individuals. Rainbow Connection Clubhouse provides life and job skill training to those who receive services from GHS. A referral would need to be made by their case manager.
 - 4. Increased need for additional case managers and navigators to walk individuals through the housing process.
 - 5. Difficulty with obtaining personal documents needed for housing, such as social security cards, birth certificates, and ID's. MBK assists with IDs and birth certificates, Secretary of State has waivers for paying a fee for ID, W. Doub has contact people at the SOS to assist.
 - 6. VISPADAT issues: does not capture all of an individual's needs which can be a barrier to programs and where an individual gets prioritized on QBNL. Approaching MSHDA with data from hired consultants that a different tool would capture individual needs more effectively.

SOAR Workgroup Report for August 2023

Attendees: William A. Open and Welcome—Bill Doub

- 1. Goals:
 - a. **Short term**: Increase the number of SOAR Trained staff using SOAR Principles and Methodology to assist with applying for benefits.
 - b. **Long term**: Establish a network of SOAR trained staff and SOAR Stakeholders to assist SHP/RRH and ESG housing assistance recipients and other vulnerable individuals with applying for benefits.

2. Outcomes:

- **a. Quantitative**: 1) Increase the number of approvals for clients receiving Federal, State, and local benefits; 2) Increase the number of SOAR Trained staff assisting SHP clients with applying for benefits. 3) Increase the amount of dollars returned to the County as a direct benefit utilizing SOAR.
- **b.** Qualitative: Establishment of a network of SOAR Trained Cadre to assist individual clients with applying for Federal and State benefits.
- 3. Results: Since the July 2023 meeting, three approvals were recorded by GHS, PATH and Legal Services respectively. Registration for Cohort D SOAR Training sponsored by MDHHS and offered through PRAINC.org was in place through July 31st. If agency staff not available to participate in the Cohort D Group Training, individual staff can pursue the SOAR training at their own pace. Two agency staff are enrolled in Cohort D and one staff is pursuing the training individually. Following up on information about MiABLE Account, staff assisted client setting up their own account.

Key Points:

- 1. From Bill: We need to discuss getting our homeless Wellness clients in the Coordinated Entry System. And we need to talk about why they are getting lost after entering the Coordinated Entry System. Maurice provided an explanation as to why Wellness clients are afraid of going to the shelter. Turning in medication will potentially expose these clients to other knowing about their HIV status.
- **2.** From Christine: As of right now I have 2 current male clients. For one of my clients I am waiting for records to come through. And for the other client I'm just waiting for him

to come to my office to sign. I even offered to go to him, but he was so transient he said, "No". Latter client did not follow thru with Christine,

From Bill: Remember the SOAR process is outreach and engagement. It takes time to build relationships, to outreach, and to engage with clients both within our bureaucratic world and within the world of the consumers we serve.

- **3.** From Cherise: I am SOAR certified, and it has been a challenge. Bill and I have a mutual client and you know it has been a struggle. But we're moving there one step at a time. We were able to get that evaluation moved up. So that's happening, I believe, next week. So that's going to help us. Hearing has been postponed. Bill Doub has agreed to represent our mutual client at his upcoming hearing. Received report from testing clinic and forwarded results along with up-to-date GHS records to the Hearing Office. Next Step: Schedule meetings with client and Cherise to prepare client for his hearing.
- **4.** From Bill: Bill thanked Cyndi for sending him a MRS report (Medical Summary Report) on a client.
 - **a.** From Bill: Remember, folks, it's not about the diagnosis of a client. It's about their ability to function on a daily basis.
 - **b.** From Bill: When we make conclusions it's important that these conclusions are backed up both in the body of the report and in the medical evidence that we cite.
 - **c.** From Bill: If we go to a hearing our job as a representative is to elicit testimony, if we are allowed to make opening remarks we must show where the information is buried in the medical records before we ask a judge to examine the medical records.
 - **d.** From Bill: When we're presenting a claim, the burden of proof is on us. We must show proof that a client can't work.
 - e. From Bill: If we submit a Medical Summary Report that is co-signed by another healthcare provider, we need to make sure the co-signer has had direct contact with the claimant. This comment was offered by the Administrative Law Judge at a recent hearing.
- **5.** From Maurice: Many people are worried about being associated with Wellness and many of our clients want their information private.
 - **a.** From Bill: Reach out to your clients and make it very clear that their information is private and confidential and will be released after written permission is obtained and the information obtained or released is directly related to the person's claim.

6. From Bill: Our underlying message here is all about social justice, and how we can make it real for everybody here. Everything we do is outreach and engagement. SOAR is a critical intervention step.

SOAR Works Training (provides 20 CEUs)

- Next Cohort will be announced in October for FY 2024.
- Training can be done individually or in a group cohort.
- There is a SOAR cheat-sheet in Module 12- Bill can send this if interested.
- Group discussion focused on the amount of time needed to complete the training. Yes...There is a lot of paperwork time involved; however, the process works and the result, that of becoming a credentialed SOAR Provider is critical for clients to sustain their housing.
